MINUTES OF THE NATIONAL ANNUAL GENERAL MEETING OF THE CANCER ASSOCIATION OF SOUTH AFRICA (CANSAS)

**HELD ON 10 OCTOBER 2019 AT CANSAS BEDFORDVIEW OFFICE
26 CONCORDE ROAD WEST, BEDFORDVIEW 2008**

1. OPENING AND WELCOME

The President of CANSAS, Mr Bugs Pancha, welcomed all present to CANSAS's 88th Annual General Meeting, CANSAS members, members of the Board of Directors, our Governors, and Provincial Chairpersons, Senior Management, award winners and special guests.

The President extended a special welcome to all cancer survivors present.

The President of CANSAS introduced the CANSAS's Board of Directors :Chairperson Derek Foster, vice-chairperson Prof Patrick Arbuthnot, Dr Martin Mandew, Dr. Rosie Mngqibisa, Ms Vuyokazi Memani-Sedile, Judge Faan Hancke, Elize Joubert (CEO) and Rudolf van Jaarsveld (CFO). He introduced the Governors present: Prof Raj Naidoo and Prof Leon Brummer as well as the Chairperson of Unit Council Northern Business Unit, David Lucas.

Dr Martin Mandew blessed the proceedings.

2. CONSTITUTION OF THE MEETING

The President confirmed that all members present had signed the attendance register and tabled the apologies from the following members: Mr Bothwell Mazarura, Mr Kobus Smit, Prof Louis Goedhals other apologies to mention: Mr Terry Booysen from Corporate Governance Framework, Dr Vicki Pinkney-Atkinson from SA NCD Alliance, Carl Queiros, CEO from CHOC, Johan Bosman, Chairperson of Unit Council: Southern Business Unit, Dr Henk Jooste, Chairperson of Unit Council: Central Business Unit and Prof Paul Ruff, member of CANSAS Research Committee.

The CFO, Rudolf van Jaarsveld, reported that the attendance register indicated 21 members were present, and all business units were represented which constitute a quorum. The President declared the meeting duly constituted and opened.

3. NOTICE CONVENING THE MEETING

In accordance with the Memorandum of Incorporation of the Cancer Association of South Africa (CANSAS), the notice of the Annual General Meeting was advertised within the prescribed 15 days' notice of this meeting.

4. CONFIRMATION OF THE PREVIOUS YEAR'S AGM MINUTES

The approval of the minutes of the National Annual General Meeting held on 20 September 2018 were proposed by Mr Derek Foster and seconded by Prof Michael Herbst.

5. CHAIRPERSON'S REPORT

The Chairperson of the Board of Directors: Mr Derek Foster conveyed his message, which was also available in the Integrated Report.

6. COUNCIL OF GOVERNORS

The President explained that the Governors stated that they needed to revisit the roles and responsibilities of the Governors in the organisation. The CANSA Board of Directors and Council of Governors evaluated the existing charter of the Council of Governors against the framework of good governance set by the King IV report. The evaluation concluded that the duties of the Council of Governors as set out in the Charter of Governors has been replaced by the responsibilities of the Board of Directors as contained in CANSA's Articles of Association and in Part 6.3, Principle 9 of King IV. The Board resolved that the Council of Governors be disbanded and the current Governors be absorbed in other existing governance structures on Business Unit levels.

To effect this amendment the following clauses will be removed from the existing MOI:

- Clause 7.11.6
- Clauses 7.12.1 – 7.12.3
